Section 3. Quorum
The presence in person of not less than one-third (1/3) of the entire membership, excluding Ex-Officio members and Guests of the entire council entitled to vote shall be necessary to constitute a quorum for the transaction of business at any meeting. A simple majority, (51%) of the quorum present, will be considered to be the majority for any vote on a council issue, unless otherwise stipulated in these By-Laws. Based on 35 members a quorum is 12.
